FACTSHEET: AMENDMENTS TO STOCK EXCLUSION REQUIREMENTS AUGUST 2021





The stock exclusion rules released under the NPS-FW last year referred to low slope maps which had many inaccuracies. These rules have been amended to use a more specific program designed to reduce exclusion on sloped land.

DO I NEED TO EXCLUDE MY STOCK FROM LAKES AND WIDE RIVERS?



DEFINITIONS

Stock: includes beef cattle, dairy cattle, dairy support cattle, deer, or pigs (but does not include any feral animal). Dairy support cattle refer to all replacement stock (100kg weaned calf) through to carryovers and MA cows. The regulations do not apply to sheep.

Stock exclusion: is a permanent fence with dug or driven posts and at least two hot wires; post and batten or deer fencing. A 3-metre set back from the bed is required for any new fences installed after 3 September 2020.

Wide river: waterways with a bed that is wider than 1 metre at any point, this may go dry over summer. On its own a wide riverbed does not require the exclusion of beef cattle and deer.

Intensively grazed: includes break feeding, grazing on annual forage crops or grazing on pasture that has been irrigated with water in the previous 12 months.

Identifying land between 5-10 degrees slope: This is done using 'local terrain averaging' to average slope aggregated over 4.5 hectare blocks for land between 5-10 degrees, this may include neighbouring land parcels to your property.

Natural Wetlands are permanently or intermittently wet areas, shallow water, and land water margins that support a natural ecosystem of plants and animals that are adapted to wet conditions.

NB: Land with slope between 5-10 degrees may need fencing but this will be managed under your FW-FP.
